Course Synopsis:

General comments on human rights and historical developments of Human rights in the world. Sources of international human rights law, International Bill of Rights (UDHR, ICCPR, and ICRSCR), the core Human Rights Treaties and Limitations of Human Rights enjoyment, Human

Rights Implementation Mechanism; International: a) Charter base mechanism, b) Treaty based mechanism; Regional Human Rights mechanisms; Domestic Implementation Mechanism. United Nations, ECOSOC, OHCHR, Universal Periodic, Review, special rapporteurs of the UN etc. National and international human rights defenders like Human Rights Watch, Amnesty International etc and in Bangladesh: National Human rights Commission.

The background and development of humanitarian law (HL), sources of the HL (Hague Regulations, Geneva Conventions, Rome Statue, ICJ etc.), classifying conflicts and interplay-human rights law and humanitarian law (when does HL apply, Armed conflicts both national and international, internal disturbances, tensions etc.), Conduct of hostiles, Occupation law (occupation of a territory by hostile army, Huge Regulation 1907, Fourth Geneva Convention 1949 and Additional Protocol 1 of 1977), protection of Civilians and Children (Convention on the Rights of the Child and its optional Protocol, child soldiers, etc.), Transitional justice, International Crime Tribunals, Red Cross in humanitarian conflicts.

Course Objectives (CO):

The objectives of this course are to:

- **1.** Having knowledge about the concept of International Law, human rights and humanitarian law and historical developments
- 2. Familiarize students with the implementation mechanisms of human rights and humanitarian laws;
- **3.** Study fundamental issues of international conventions, international bill of rights, ICJ human rights defenders, conduct of hostiles, occupation law, transitional justice etc.
- **4.** Provide students with the tools for further study of institutions relating to the Human Rights and Humanitarian law.

Learning Outcomes (LO):

Upon completion of the course, the students will be able to:

- **1.** the nature and scope of Human Rights and Humanitarian Laws;
- 2. the rationale of the international law and sources of law particularly in the area of human rights and humanitarian perspective;

- **4.** To build the intellectual, theoretical, and practical skills on the Human Rights and humanitarian Laws.
